3. How We Use Your Information

We use your information to:

Process and manage party bookings

Respond to enquiries

Provide customer support

Personalise your party experience

Process payments

Improve our website and services

Send important booking updates

Send marketing emails (only if you have opted in)

We will never sell your personal data to third parties.

4. Children's Data

As a children's party business, we may collect limited information about children (such as first name and age) solely for the purpose of planning and delivering the party experience.

We only collect this information from a parent or legal guardian.

We do not knowingly collect data directly from children.

5. Legal Basis for Processing

We process your personal data under the following lawful bases:

Contract – to fulfil your booking

Legitimate Interest – to operate and improve our services

Consent – for marketing communications

Legal Obligation – where required by law

6. Payment Information

Payments are processed securely through trusted third-party payment providers. We do not store full card details on our systems.

7. Sharing Your Information

We may share your information with:

Payment processors

Booking or website platform providers

Professional advisers (e.g. accountants)

Legal or regulatory authorities if required

We only share information necessary to provide our services.

8. Data Storage & Security

We take appropriate security measures to protect your personal data from unauthorised access, alteration, disclosure or destruction.

Your information is stored securely and retained only for as long as necessary for business or legal purposes.
